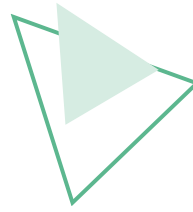

Brand Rate of Duty Drawback

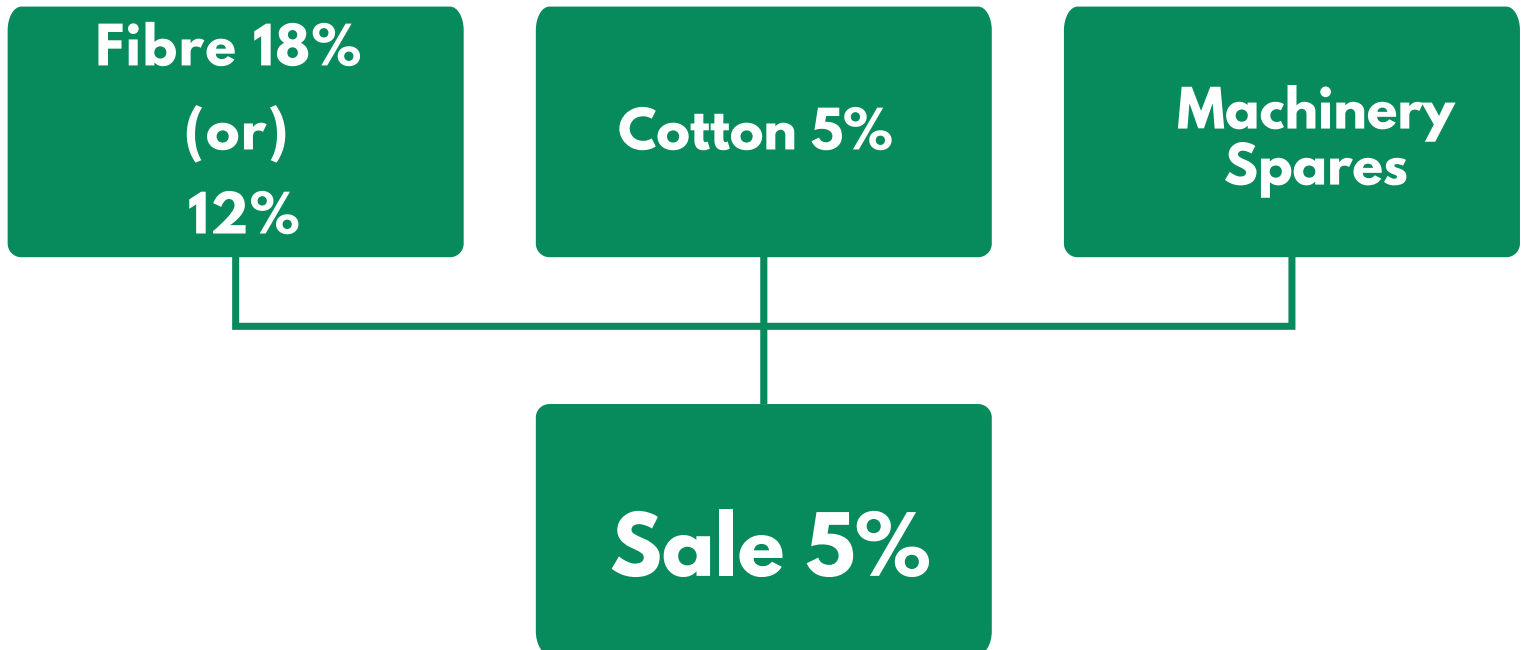
- Brand Rate of Duty Drawback helps exporters get a refund on the duties they paid for import materials used in making products for export. If the usual refund rate (AIR) doesn't cover at least 80% of the duties, or if there isn't a set rate, the exporter can request a special refund rate.

Spinning Mill GST Refund Case Study

When the input tax credit available on inputs is greater than the GST rate applied to the final product, it leads to an inverted duty structure. This raises the manufacturer's tax burden, as he is buying inputs at a higher tax rate than what he is charging customers for the final product. The higher tax burden on the manufacturer could ultimately result in higher customer pricing.



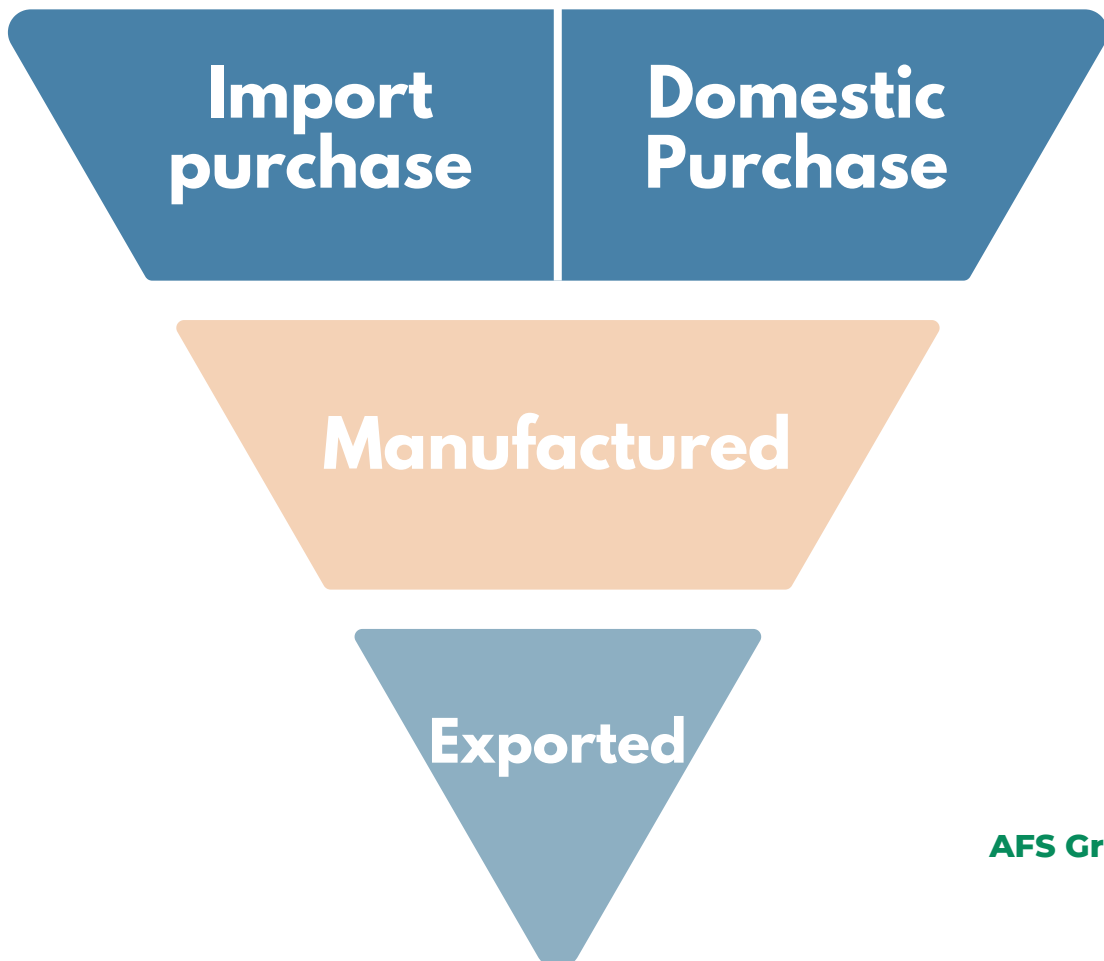

Brand Rate of Duty Drawback

Brand Rate of Duty Drawback is a unique facility provided to exporters for a rebate of actual duty incidence suffered by an export product. Under the Brand Rate mechanism, a specific

Duty Drawback rate can be applied for by the exporter if the export product does not have an AIR or the available AIR neutralises less than 80 per cent of the duties paid on materials used in the manufacture of export goods.



HOW IT WORKS



Working Capital

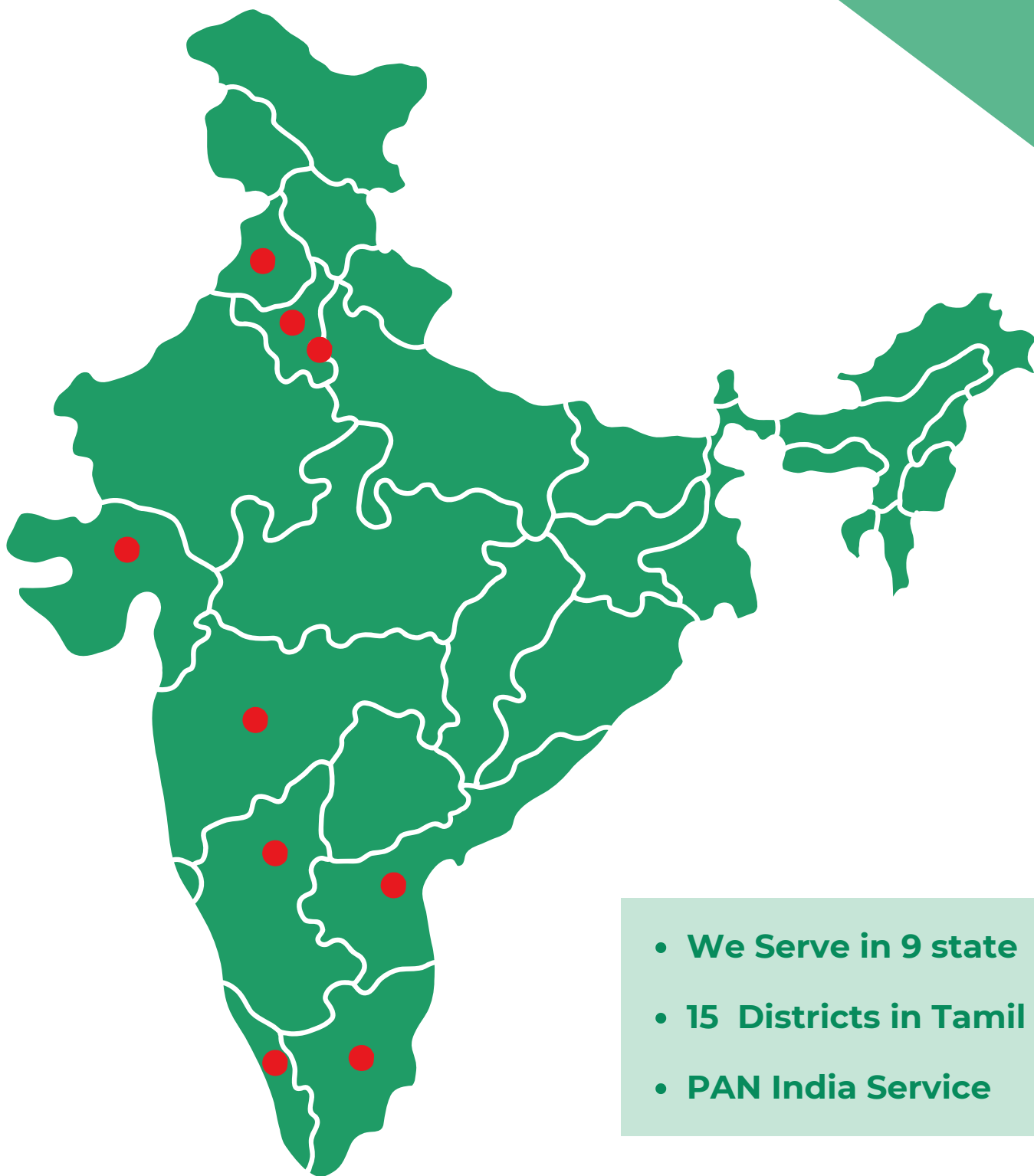
